

# M.C. Headrick Free Enterprise Award Nomination Form

## ***Purpose***

The M. C. Headrick Free Enterprise Award is the highest and most prestigious award given by the Cleveland/Bradley Chamber of Commerce. The purpose of the award is to focus on the Free Enterprise system and to honor the memory of one of the most outstanding businessmen Cleveland and Bradley County has ever produced. M. C. was a man who believed wholeheartedly in the fundamental concepts of the Free Enterprise System. He believed it this way:

*"Put men on their own to make economic decisions,  
and let them reap the rewards or lack of rewards from those decisions."*

## ***Criteria***

Nominations will be evaluated according to the following criteria:

- ◆ **Resume**—A resume' of the candidate must be submitted to the selection committee with any nomination, and the committee may ask for additional information.
- ◆ **Staying Power**—A substantiated history as an established business. Minimum of 10 years in business. (Nominee must have been principal for that time.)
- ◆ **Economic Success**—Nominees considered by the committee will be individuals who have climbed the ladder of economic success through their initiative and effort.
- ◆ **High Moral/Ethical Standards**—The recipient must be a person of high moral and ethical standards who would exemplify the best of the free enterprise system.
- ◆ **Growth in Number of Employees**—A benchmark to judge the impact of the business on the job market.
- ◆ **Increase In Sales And/Or Unit Volume**—An indication of continued growth.
- ◆ **Chamber Membership**—The firm of the nominee shall be a member in good standing of the Cleveland/Bradley Chamber of Commerce for the fiscal year 2023.
- ◆ **Evidence Of Contributions By The Nominee To Aid Community-Oriented Projects**—While not a *primary* consideration, the nominee's involvement in or contributions to civic/community, charitable, religious and professional organizations will be considered.

## ***Format***

The nomination should be in narrative form and must contain the following

1. Cover Sheet: The cover sheet or introductory page must include:
  - Nominator Information: Name, address, and telephone number
  - Nominee Information: Name, address and telephone number. Name and type of nominee's business.
  - Statement: A clearly articulated statement of why the nominee deserves to be selected and recognized.
2. Nomination Information: All selection criteria points outlined must be addressed as detailed on the attached form.

## ***Deadline***

Delivery: Mail or hand deliver the nomination by Friday, Dec. 15, 2023

The nominee should be available to attend the Chamber's Annual Meeting in January 2024.
